The project Regions4PerMed contributes to the achievement of the objectives of the European Health Innovation Strategy launched in 2011 with the European Council Conclusion: towards modern, responsive and sustainable health systems (2011/C 202/04) devoted to the modernisation of the European Healthcare system.

Regions4PerMed [www.regions4permed.eu] aims at building a policy instrument able to reinforce the inter-regional collaboration and enable the transition from REACTIVE healthcare system (based on episodic and acute care model) to PREVENTIVE (stratifying at-risk individuals and ensure that preventive action is taken to intervene well before the onset of symptoms, let alone illness) and PREDICTIVE (leverage and integrate cutting-edge technologies to not only stratify risk, but even predict risk and intervene even further upstream) systems.
